# L.12/12 TO DETERMINE WHETHER THERE MAY BE REASONABLE CAUSE TO REVOKE OR SUSPEND A HACKNEY CARRIAGE DRIVER LICENCE – WHETHER THE DRIVER IS 'FIT AND PROPER'

Consideration was given to an exempt report which sought to determine whether there was 'reasonable cause' to suspend or revoke a Hackney Carriage Driver Licence in accordance with Section 61 of the Local Government (Miscellaneous Provisions) Act 1976, as amended by Section 52 of the Road Safety Act 2006.

The Chairman reminded the Committee that this item had been deferred from the meeting held on 7 June 2012, in order that the licence holder be given the opportunity to attend and address the Committee (Minute L.5/12 refers).

The Licensing Officer briefly reiterated the key points, and then the licence holder was invited to make representations to the Committee.

Once the Committee and the licence holder were both content that they had no further points or questions to raise, the meeting was adjourned to consider the application.

The Committee proceeded to consider the application in the company of the Solicitor.

#### The Decision

The Chairman then proceeded to ask the Solicitor to announce the decision as follows:

'In consideration of all of the evidence, the Committee has decided to suspend the Hackney Carriage Driver Licence of the licence holder, with immediate effect, for a period of three months. This suspension will end on 18 September 2012. '

# L.13/12 TO DETERMINE WHETHER THERE MAY BE REASONABLE CAUSE TO REVOKE OR SUSPEND A HACKNEY CARRIAGE DRIVER LICENCE – WHETHER THE DRIVER IS 'FIT AND PROPER'

Consideration was given to an exempt report which sought to determine whether there was 'reasonable cause' to suspend or revoke a Hackney Carriage Driver licence in accordance with Section 61 of the Local Government (Miscellaneous Provisions) Act 1976, as amended by Section 52 of the Road Safety Act 2006.
